

## Supplier Notification Letter

Dear Supplier,

The intent of this letter is to inform you of recent regulations impacting the supply of products or materials to Scionix Holland BV and to request your cooperation in addressing this important matter.

On August 22, 2012, the U.S. Securities and Exchange Commission (“SEC”) adopted final rules implementing Section 1502 of the Dodd-Frank Wall Street Reform and Consumer Protection Act. These rules impose disclosure and due diligence requirements on publicly-traded companies that manufacture products containing certain minerals designated as “conflict minerals”: gold, columbite-tantalite (coltan), cassiterite, wolframite, and their derivatives, tantalum, tin and tungsten, that have been mined or smelted in the Democratic Republic of the Congo (the “DRC”), Republic of Congo, Angola, Burundi, Central African Republic, Rwanda, South Sudan, Tanzania, Uganda or Zambia.

For some of our customers Scionix need to comply with these rules, Scionix will conduct due diligence inquiries of its supply chain regarding conflict minerals that are included in any products, materials or supplies that are delivered to Scionix.

We recognize that in order to complete this inquiry you may be required to ask your suppliers (and they may have to ask their sub-tier suppliers) for this information. By completing this disclosure form, you will assist Scionix in creating an efficient approach to addressing these new regulations.

As a condition of all purchase orders issued, Scionix will require its suppliers to complete the Conflict Minerals Disclosure if their products contain conflict minerals.

Scionix is requesting information from your organization about conflict minerals. You are being asked to report the required company-level data and, if known, the smelter data for tin, tungsten, tantalum and gold in your products supplied to Scionix by January 31, 2013.

We recognize that you may be receiving similar queries from several of your customers, and that each may be requesting information in different formats. If you will be undertaking a conflict minerals inquiry apart from this one for Scionix and if you expect to prepare a detailed disclosure that would include the product(s) you do or expect to supply to Scionix, please submit a copy of that disclosure or report to the Scionix purchasing representative identified in your purchase requisition or request for quotation and we will quickly determine whether it also satisfies Scionix due diligence process. Otherwise, we encourage you to begin the process necessary to put you in a position to respond in a timely manner to the new regulatory compliance procedures described above.

Please use the Template Conflict Minerals (attached) for reporting your information.

If it is not possible to provide reports through this template, you may return a completed Electronic Industry Citizenship Coalition and Global e-Sustainability Initiative (“EICC/GeSI”) Conflict Minerals Reporting Template including all smelter information for all of your conflict mineral products.

To ensure that Scionix clearly understands your company's responses, certain questions will require further explanation in the comments section of the tool. This guidance applies regardless of the chosen reporting method.

### Questions 1-6

**Question 1: Are any of the following metals necessary to the functionality or production of your company's products that it manufactures or contracts to manufacture?** It is expected you will answer "yes" to these questions if your product contains any amount (even trace amounts) of the minerals. If you answer "no" for any of the derivatives in this question, you must enter the specific reason in the comments section.

Examples of specific reason listed (not limited to these):

- No - because my products do not contain, in any form, any of the derivatives listed.
- No - because these derivatives are used for production and no amount is left on/in the product.
- No - we do not believe that these derivatives are necessary to the functionality of the product. Note: this answer requires technical documentation on your statement to be supplied at a future date.
- No - any other explanation that supports the conditions listed in the question

**Question 2: Do the following metals (necessary to the functionality or production of your company's products) originate from the DRC or adjoining countries?** If your products contain the mentioned derivatives and you wish to answer "no", you must provide the names and locations of your smelters. If you cannot provide smelter-level information and your products contain these derivatives you must answer "uncertain or unknown" or "yes", if known.

**Question 3: Do the following metals (necessary to the functionality or production of your company's products) come from a recycler or scrap supplier?** If your products contain the mentioned derivatives and you wish to answer "yes", you must be able to provide proof these derivatives come from recycled or scrap sources. A brief description how you can support your "yes" must be provided.

**Question 4: Have you received completed Conflict Minerals Reporting Templates from all of your suppliers?** Regardless of your answer, a specific percentage of your suppliers that you contacted must be provided. Example: We contacted 75 percent of our supply chain and received responses from 50 percent of those contacted.

**Question 5: For each of the following metals, have you identified all of the smelters your company and its suppliers use to supply the products included within the declaration scope above?** If you wish to answer “yes”, you must return the names of the smelters in the appropriate tab. Complete mine and smelter location address must be submitted for any smelter that is not included in the dropdown menus.

**Question 6: Have all of the smelters used by your company and its suppliers been validated as compliant in accordance with the Conflict-Free Smelter Program and listed on the Compliance Smelter List for the following metals?** If you wish to answer “yes”, you must provide a complete list of your smelters in the appropriate tab.

**Answer the following Questions at a Company level.** Any questions in section a-j with a “no” answer requires an explanation in the comments section.
